



Aerial of Elmgrove Point



Partnerships



- Countryside Partnerships have started to mobilise on site at Elmgrove Point
- We will be starting work to erect the scaffolding in August/September 2024
- We will put up scaffolding on all elevations of the building, beginning on the Southport Road side
- We will be removing the cladding from all elevations of the building and replacing with new fire compliant cladding

- We need access to all flats to complete conditions surveys of your properties from Monday 22nd July. This should only take about 15 minutes, and you can sign up for a time convenient to you today
- When the time comes, we will inform residents at least two weeks before you need to clear your balconies/terraces so that we can complete decking works
- We will also need to work on fire doors within your flats from October 2024, and we will work to organise this at a time that works best for you

Cladding stripping work	December 2024	October 2025
Replacing for new cladding	January 2025	January 2026
Internal door works / Electrical Box works	October 2024	September 2025
Replace balcony decking	March 2025	July 2026
All works finish	August 2026

Our Programme: What to expect (Site specific) Countryside Partnerships

Playground – out of action

- During our works, for your safety we will close off the playground in the courtyard
- You can use the Glyndon Playground on Villas Road as an alternative (10 minute walk)

Walkways working

 We will need full access for periods of time, with residents having limited access. We will let know when carrying out the works

CCTV

For your safety, we will have CCTV set up around the entire building

Our Programme: What to expect (General)



At different stages of our works, the day-to-day impact will vary. This is what you can expect, and what we're doing to minimise the inconvenience:

Impact		We will
Light and Overlooking	Scaffolding will be present outside of your window/balcony, reducing natural light and increasing overlooking	Work on sections of the building at a time to minimise impact
Noise	Aspects of our Fire Safety Remediation works will be unavoidably noisy	Monitor our noise to ensure it remains within permitted levels Avoid working in the evenings or at the weekend

Our Programme: What to expect (General)



At different stages of our works, the day-to-day impact will vary. This is what you can expect, and what we're doing to minimise the inconvenience:

Impact		We will
Scaffolding	Scaffolding will inconvenience a few residents more than others e.g. it may mean you have limited access to your balcony for a period, or must exercise additional caution on your balcony white netting will be placed over balconies when scaffold is in place to reduce the risk of trespassers. Communal terraces will be out of action for the duration of the works.	Be in touch with all affected residents directly, and keep you updated
